

## NOTICE OF CAMERA VIDEO AND AUDIO RECORDING

THIS NOTICE IS TO SERVE AS APPROPRIATE DISCLOSURE FOR ANY/ALL TRANSPORTERS BUT NOT LIMITED TO EMPLOYEES, CUSTOMERS, MAINTENANCE CREWS AND ANYONE WHO INTERACTS WITH THE PROPERTY OF BEETRANS VEHICLES AND PROPERTIES. DURING THE DURATION OF THE INTERACTION SHIFT/DAY, WITH/FOR/BY THE EMPLOYEE, CUSTOMER, MAINTENANCE CREW OR ANYONE ALL SHALL BE FILMED WHILE OPERATING THE MACHINERY NAMED AMBULETTE VANS. AMBULATORY CARS AND ON THE BEETRANS PROPERTIES USED TO FURNISH BUSINESS ON THE BEHALF OF THE BUSINESS. THE USEAGE OF VIDEO CAMERAS WILL ALLOW BEETRANS TO RECORD VIDEO AND AUDIO. THE VIDEO LOGS SHALL BE KEPT IN SEQUENCE TO COENCIDE PAPERWORK FILINGS THAT ARE TO BE KEPT AS A RECORD AS OBLIGATION BY THE OBLIGOR BEETRANS FOR THE LIMITS SET BY THE (ODM) OHIO DEPARTMENT OF MEDICAID RECORD KEEPING PROCEDURES (PLEASE REFER TO OAC FOR TIME LIMITS). THE VIDEO AND AUDIO WILL BE USED AS PHYSICAL PROOF BUT NOT LIMITED TO: PROOF OF WHEREABOUTS, APPROPRIATE PROCEDURES, PRACTICES OF THE EMPLOYEES, TRAINING PURPOSES, EMPLOYEE TRAINING VIDEO, VERIFICATION OF CONTENTS OF CONVERSATION, USE OF CRIMINAL AND CIVIL FILINGS, COURT PROCEDURES AND COMMERCIAL USAGE. BY SIGNING THE NOTICE YOU UNDERSTAND THAT THE VIDEO AND/OR AUDIO CAN BE PROVIDED BUT HAS NO OBLIGATION FROM THE COMPANY BEETRANS ON THE BEHALF OF ANYONES BENEFIT BUT BEETRANS. THAT RECORDING THE VIDEO AND AUDIO IS A FORM OF LEGAL PROTECTION AGAINST LAW SUITS, COURT PROCEEDINGS WHETHER CRIMINAL OR CIVIL FOR THE USE OF BEETRANS BY BEETRANS AND NOT SUBJECT TO BE PROVIDED TO ANY ENTITY, PEER, PERSON, EMPLOYEE OR BUSINESS WITHOUT APPROPRIATE WARRANT FILINGS AND PROCEDURES FURNISHED BY THE STATE OF THE BUSINESS. IF ANYONE IN THE AUDIO OR VIDEO IS SEEN OR HEARD BEING VIEWED IS IN VIOLATION OF ANY PRACTICE PROCEDURE OF BEETRANS MAY BE TERMINATED, HAVE CRIMINAL OR CIVIL FILINGS AGAINST THEM AND BE REMOVED FROM THE COMPANY IN ENTIRETY. THIS SERVES AS PROTECTION FOR THE AUTHORIZED COMPANY BEETRANS TO ASSURE PATIENTS THAT THE SAFETY AND LIABILITY OF THE COMPANY HAS BEEN FUFILLED ENTIRELY BY THE COMMITMENT OF THE CONTRACT APPOINTED BY THE CONTRACT COMPANY/BROKER. WITHOUT ANY VIOLATION OF ANY PERSON OR PROPERTY OF THE NAMED INDIVIDUAL/S. BEETRANS IS A NON EMERGENCY MEDICAL TRANSPORTATION COMPANY AND MAY BE REQUIRED TO TRANSPORT A PATIENT OR PATIENTS AND FAMILY MEMBERS BUT NOT LIMITED TO SPOUSES TO OR TO AND FROM (ROUND-TRIP) VARIOUS LOCATIONS BUT NOT LIMITED TO LONG DISTANCE TRANSPORTATION TO EXTENDED CITIES AND STATES TO OFFER THE TRANSPORTEE A MORE SUBSTAINABLE ENVIROMENT FOR THE HEALTH AND WELLNESS OF THE INDIVIDUAL ON THE CONTRACT.
